Westwind has several seasoned operators that have been with the division for up to 30 years, those operators are very valuable, and we appreciate their commitment. Starting next year, there will be a new funding framework for transportations departments. The Board thanked Mr. Cahoon and asked him to pass along their appreciation to the transportation department staff and bus operators.
