1. This is a binding legal agreement. Clarify any questions or concerns before signing. As an Individual participating in the <INTERNATIONAL TRAVEL> and its affiliated districts (collectively the "Organization"), the International Travel activities may include, but are not limited to: travelling to the location, events, games, rides including roller coasters, animal exhibits, orientational or instructional sessions or lessons, (collectively the "Activities"), the undersigned, being the Individual and Individual's Parent/Guardian (collectively the "Parties"), acknowledge and agree to the terms outlined in this agreement.
2. I am the Parent/Guardian of the Individual and have full legal responsibility for the decisions of the Individual.

Description of Risks

3. The Individual is participating voluntarily in the Activities. In consideration of that participation, the Parties hereby acknowledge that they are aware of the risks, dangers and hazards that they may be exposed to, which include, but are not limited to:
 - A. Contracting COVID-19 or any other contagious disease;
 - B. Flight delays or cancellations;
 - C. Stolen or lost items including a passport or other documentation;
 - D. Poor roads;
 - E. Lower standard of medical care or facilities;
 - F. Lower standard of food quality and preparation;

- G. Lower standard of public health;
 - H. Diseases related to destination;
 - I. Terrorism;
 - J. Issues with customs, immigration or visas;
 - K. Destabilising political or economical states;
 - L. Lost baggage;
 - M. Risks involved with activities planned while travelling including:
 - i. Exerting and stretching various muscle groups;
 - ii. The failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment, resulting in injury;
 - iii. Abrasions, sprains, strains, fractures, or dislocations from slipping, jumping, falling, or running;
 - iv. Privacy breaches, hacking, technology malfunction or damage;
 - v. Sickness, nausea, headache, and other sicknesses from participating in rides or viewing, including but not limited to roller coasters, animal exhibits, rides, and other Activities;
 - vi. Physical contact with other Individuals;
 - vii. Not wearing appropriate attire or footwear;
 - viii. Failure to act safely or within the Individual's ability or within designated areas;
 - ix. Negligence of other persons, including Individuals, or employees;
 - N. Extreme weather conditions;
 - O. Travel to and from location
4. The Parties understand and acknowledge that:
- A. The Travel and associated Activities have foreseeable and unforeseeable inherent risks, hazards and dangers that no amount of care, caution or expertise can eliminate, including without limitation, the potential for serious bodily injury, and in rare occurrences, permanent disability, paralysis and loss of life;
 - B. The Organization has a difficult task to ensure safety and it is not infallible. The Organization may be unaware of the Individual's health, fitness or abilities, may give incomplete warnings or instructions, may misjudge weather or environmental conditions, and the equipment being used might malfunction; and
 - C. The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization and COVID-19 is extremely contagious. The Organization has put in place preventative measures to reduce the spread of COVID-19; however, the Organization cannot guarantee that the Individual will not become infected with COVID-19. Further, attending the Activities could increase your risk of contracting COVID-19.

5. In consideration of the Organization allowing the Individual to participate in the International Travel and Activities, the Parties agree:
 - A. That the Individual's mental and physical condition is appropriate to participate in the Travel and Activities;
 - B. That personal injury can and may occur to the Individual Child, and I hereby authorize the Travel organizer, its officers, or representatives to seek and consent to emergency medical attention for the Individual Child and further agree to be liable for and to pay all costs incurred in connection with such medical attention;
 - C. To comply with the rules and regulations for participation in the Travel and Activities;
 - D. To a rescheduling of the Travel, should unforeseen circumstances affect the viability of these Travels;
 - E. That if the Individual observes an unusual significant hazard or risk, the Individual will remove themselves from participation and bring such to the attention of an Organization representative immediately;
 - F. The risks associated with the Travel and Activities are increased when the Individual's abilities are compromised, for any reason, including, but not limited to fatigue, muscle strain, compromised vision, minor injury, and the Individual agrees not to participate if impaired in any way;
 - G. That it is the Individual's sole responsibility to assess whether any Travel and Activities are appropriate for the Individual. By the Individual commencing an Activity, they acknowledge and accept the suitability and conditions of the Activity;
 - H. That COVID-19 and all other communicable diseases are contagious in nature and the Individual may be exposed to or infected by COVID-19 or any other communicable disease, including communicable disease exposures arising out of supervision, instructions, recommendations, warnings or advice given or which should have been given, and such exposure may result in personal injury, illness, permanent disability or death, and voluntarily agree to assume all of the foregoing risks;
 - I. That the Parties acknowledge that they have considered and disclosed to the School Board all physical or mental health conditions, allergies, intolerances, and any other risks associated with these conditions, that could potentially affect the Individual's ability to safely participate in the Activities. Permission for the Individual to participate in the Activities is therefore based upon belief that the Individual does not have any intolerances, allergies, or health conditions that have not been disclosed, and could affect the Individual's ability to safely participate in the Activities.
 6. In consideration of the Organization allowing the Individual to participate, the Parties agree:
 - A. That the Parties are not relying on any oral or written statements made by the Organization or their agents, whether in a brochure or advertisement or in individual conversations, to agree to be involved in the Activities; and
 - B. That the Organization is not responsible or liable for any damage to the Individual's vehicle, property, or equipment that may occur as a result of the Activities

- 7. The Parties expressly agree that this Agreement is intended to be as broad and inclusive as is permitted by law and that if any of its provisions are held to be invalid, the balance shall, notwithstanding, continue in full legal force and effect.

The Parties acknowledge that they have read this Agreement and understand it, that they have executed this Agreement voluntarily, and that this Agreement is to be binding upon themselves, their heirs, their spouses, parents, guardians, next of kin, executors, administrators and legal or personal representatives.
