Discussion & Information Item

- Transportation Report Mike Cahoon
 - i. Mike Cahoon, Transportation Supervisor gave a brief report to the Board. A replacement mechanic has been hired, he started earlier in April. Three of the seven Magrath area bus operators have resigned or retired over the past few months. The process of hiring replacement drivers is going well. The transportation funding submission has been completed. A driving school is up and running, and new bus operators are being trained.
- WAS Principal Mike DeVuyst
 - i. Mr. Mike DeVuyst, the Westwind Alternate School principal, shared some exciting news with the Board. The Westwind Alternate School Parent Council Chair was able to secure a scholarship exclusively for home education students. The Friesen Family Foundation Scholarship Fund will annually provide one non-renewable scholarship in the amount of \$1000 to a senior student who meets the established criteria. The scholarship will be awarded for a period of four years or until the fund has been exhausted. The Board thanked Mr. Devuyst and asked him to thank the parent council chair as well.
- Glenwood ball diamond request
 - i. The ball diamond in Glenwood is on Westwind School Divison property. The village is asking for a \$1000 donation toward the purchase of a machine that burns the unwanted weeds and plants on the ball diamond. After a discussion, the Board directed the Superintendent to move forward with the requested funds.
